- Louis Pasteur (1861): Utilizing swan-neck flasks, Pasteur proved that microorganisms in the air were responsible for contamination in broths. This established the principle of Biogenesis: the observation that living matter arises only from other living matter.

### The Primordial Soup and Prebiotic Chemistry

If biogenesis is the rule for modern life, how did the first cell arise? The **Oparin-Haldane Hypothesis** suggested that Earth's early atmosphere was reducing, and with energy from sunlight or lightning, organic molecules could form from inorganic precursors. This was famously tested by the **Miller-Urey Experiment**, which successfully synthesized amino acids—the building blocks of proteins—under simulated early Earth conditions.

## 2. The Endosymbiont Theory: Explaining Eukaryotic Evolution

One of the most significant leaps in biological complexity was the transition from simple prokaryotic cells to complex eukaryotic cells containing membrane-bound organelles. **Lynn Margulis** proposed the **Endosymbiont Theory** in the 1960s to explain this transition, particularly regarding the origin of mitochondria and chloroplasts.

### Mechanisms of Endosymbiosis

The theory suggests that mitochondria were once free-living aerobic prokaryotes that were engulfed by a larger anaerobic host cell. Instead of being digested, the prokaryote entered into a symbiotic relationship, eventually

While the origin of life addresses how biology began, the **Origin of Species** addresses how life diversified. Speciation is the evolutionary process by which populations evolve to become distinct species. #### Mechanisms of Reproductive Isolation

To form a new species, gene flow between populations must cease. This occurs through several isolating mechanisms:
