- Phase 3: Reception and Distribution. Upon arrival in Miami, children were sent to camps (like Camp Matecumbe) or foster homes across 35 states.

Thematic and Structural Analysis of the Narrative

In **90 Miles to Havana**, Flores-Galbis utilizes a first-person perspective through the protagonist, Julian. The narrative is structured into three distinct movements: the collapse of domestic stability in Havana, the transition through the migrant camps in Miami, and the eventual quest for family reunification. This structure mirrors the **Hero's Journey** but is grounded in the harsh realities of mid-century geopolitics.

Core Concepts and Theoretical Framework

The novel functions on several theoretical levels, primarily **Post-Colonial Theory** and **Identity Formation in Exile**. As Julian moves from a position of relative privilege in Havana to a state of "non-belonging" in a Florida camp, his character arc represents the broader Cuban-American experience.

The "90-mile" figure is actually an approximation; the distance from the Southernmost Point buoy in Key West to the Cuban coast is roughly 94 statute miles (81.7 nautical miles).

Mathematical Displacement Modeling

In migration studies, we can model the flow of refugees using a simplified gravity model of migration, which posits that the volume of migration is proportional to the population sizes of the two locations and inversely proportional to the distance between them. In the case of 1961 Cuba:

$$M = k * (P1 * P2) / D$$

Where:
M = Migration flow
P1, P2 = Populations of Havana and Miami respectively
D = Distance (90 miles)
k = Political friction coefficient (highly elevated in 1961 due to the Cold War)

The low value of **D** meant that even with a high political friction coefficient, the migration volume was substantial, as seen in the 14,000+ children of Operation Pedro Pan.

The buoy itself is a concrete-filled redirected sewer pipe, designed to withstand Category 5 hurricanes. This technical durability serves as a metaphor for the Cuban-American community's resilience. Despite the "90 miles" of turbulent water, the cultural and familial ties remained structurally sound, much like the monument itself.

Literary Devices and Authorial Intent

Enrique Flores-Galbis employs specific literary techniques to enhance the educational value of the text:

- Juxtaposition: The lush, vibrant descriptions of Havana are contrasted with the sterile, crowded conditions of the Miami camps.

- Symbolism: The "small boat" represents the precarious nature of the refugees' lives.
