The Matrix Exponential (e^{At})

Core Mechanics of Linear Systems: Controllability and Observability

Controllability

A system is said to be **completely state controllable** if, for every initial state $x(0)$, there exists an unconstrained control input $u(t)$ that can transfer the state to any final state $x(f)$ in a finite time interval. To test for controllability, we construct the **Controllability Matrix (Cc)**:

$$C_c = [B \mid AB \mid A^2B \mid \dots \mid A^{n-1}B]$$

The system is controllable if and only if the rank of C_c is equal to n (the number of states). This is known as the **Kalman Rank Condition**.

Observability

Observability is the "dual" of controllability. A system is **completely observable** if the initial state $x(0)$ can be uniquely determined from the knowledge of the output $y(t)$ and the input $u(t)$ over a finite time interval. The **Observability Matrix (Co)** is defined as:

$$C_o = [C \mid CA \mid CA^2 \mid \dots \mid CA^{n-1}]$$

The system is observable if the rank of C_o is n . If a system is not observable, it contains "hidden" states that cannot be seen or tracked via the output sensors, which is a critical failure mode in control design.

Transitioning from a mathematical model to a physical controller involves several engineering steps. Practitioners

Step-by-Step Engineering Workflow

4. **Check Structural Properties:** Verify controllability and observability. If the system is not controllable, you cannot move the poles to desired locations. If not observable, you cannot implement state feedback without an observer.
5. **Controller Design:** Use techniques such as Pole Placement or LQR (Linear Quadratic Regulator) to define the feedback gain matrix K.
6. **Observer Design (Kalman Filter):** If the full state is not measurable, design an observer to estimate $x(t)$.
7. **Discretization:** Convert the continuous controller to a discrete-time equivalent for implementation on a microcontroller using a specific sampling period (T_s).

Case Study: The Inverted Pendulum on a Cart

To illustrate the depth of linear systems theory, consider the **Inverted Pendulum**. This is a classic "unstable" system. The goal is to keep a pole balanced vertically by moving a cart back and forth.

Technical Breakdown

- **Nonlinear Model:** The dynamics involve sine and cosine terms of the pendulum angle θ .
- **Linearization:** Around the upright position $\theta = 0$, we assume $\sin(\theta) \approx \theta$ and $\cos(\theta) \approx 1$.

For linear systems $dx/dt = Ax$, we search for a symmetric positive definite matrix P that satisfies the **Lyapunov Equation**:

$$A^T P + P A = -Q$$
